WHEREAS, the City of Orange Township hereby accept the funds under the CDBG Program Year 2020 for the following projects; and



**AMENDMENT TO PY 2020 CONTRACT
CITY OF ORANGE
COMMUNITY DEVELOPMENT BLOCK GRANT**

AGREEMENT:

This agreement, made by and between the County of Essex, a body politic and corporate of the State of New Jersey, hereafter referred to as the "County" and the City of Orange, 29 North Day Street, Orange, NJ 07050, hereafter referred to as the "Sub Recipient" amends their agreement that was approved by Resolution No. R-2022-00767 of the Essex County Board of County Commissioners on September 14, 2022.

NOW, THEREFORE, in consideration of the mutual promises, covenants and agreements herein contained, the parties hereto do hereby covenant and agree to amend the agreement as follows:

EFFECTIVE DATE OF CONTRACT:

The current contract term shall continue to extend through to March 31, 2023.

SERVICES TO BE PROVIDED:

The sub-recipient shall continue to provide site improvements to the pool at Colgate Park in Orange.

COMPENSATION:

The amount of the original \$140,500 contract is increased by \$117,000 for a total amended contract amount not to exceed \$257,500.

ADDITIONAL CONDITIONS:

All other terms and conditions, certifications and representations contained in the original contract agreement and subsequent amended contracts shall remain in effect through to the termination date of this amended agreement.
