TITLE: A RESOLUTION APPOINTING CP ENGINEERS, LLC, 11 PARK LAKE ROAD, SPARTA, NEW JERSEY 07871 TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR CY 2021, JANUARY 1, 2023 THROUGH DECEMBER 31, 2023 PURSUANT TO THE ESCROW SCHEDULE, NOT TO EXCEED \$50,000 SPECIFICALLY FOR THE ZONING BOARD OF ADJUSTMENT THAT WILL BE PAID BY ESCROW FUNDS ONLY.

WHEREAS, the City of Orange Township has a need to acquire professional Engineering Services as a contract pursuant to the provisions of N.J.S.A. 19:44A-24 or 20.5 as appropriate; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires a resolution authorizing the award of contracts for "Professional Services" without competitive bids and that the contract itself be available for public inspection as set forth herein; and

WHEREAS, the City of Orange Township Zoning Board of Adjustment requires Engineering Services from professional Engineers or Engineering Consultants that are Licensed by the State Board of Professional Engineers and Nationally certified; and

WHEREAS, the Zoning Board of Adjustment Technical Review fees will be paid separately from the budget and received from establishing an escrow account that will be solely funded by developers pertaining to their specific projects; and

WHEREAS, the Director of Planning has further reviewed the required documents submitted with the fee schedule, and find them to be in compliance with Federal, State and Local laws; and

WHEREAS, the Engineering firm of CP Engineers, LLC has completed and submitted a Business Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the City in the previous one (1) year, except that the year 2005 is an exception to this requirement as the one year immediately preceding the effective date of the law, as that term is defined below, and that the contract will prohibit CP Engineers, LLC from making any reportable contributions throughout the term of the contract.

NOW, THEREFORE, BE IT RESOLVED by the Zoning Board of Adjustment of the City of Orange Township, New Jersey as follows:

1. The Zoning Board of Adjustment hereby approves and directed to execute the attached Agreement with CP Engineers, LLC specifically set forth in the attached proposal for one year effective January 1, 2023 through to December 31, 2023.
