WHEREAS, a determination has been made that there is a need to store City of Orange Township records in the Clerk's Office offsite to avoid water damage to records caused by periodic weather events; and

WHEREAS, the City of Orange Township is a member of the Keystone Purchasing Network, a cooperative purchasing program, and desires to use the cooperative for records management services; and

WHEREAS, under Contract #KPN-201701-01, Keystone Purchasing Network awarded a contract for records management services to FileBank, Inc.; and

WHEREAS, the City of Orange Township wishes to enter into a contract with FileBank, Inc., 23 Thornton Road, Oakland, N.J. 07436, for records management services of files in the Office of the City Clerk in an amount not to exceed \$15,000.00; and

WHEREAS, FileBank, Inc.'s records management services will be purchased through the Keystone Purchasing Network (#KPN-201701-01) through its representative FileBank, Inc. at a cost not to exceed \$15,000.00 for records management services of files in the Office of the City Clerk; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto, certifying that funds will be available for this purpose in Account 3-01-20-120-000-528 contingent upon Council approval and inclusion of said item in the Temporary Budget and adopted 2023 Budget, there will be sufficient funds to contract FileBank, Inc.

## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, NEW JERSEY, THAT:
