Janine Bauer, Esq. requested to see the layout and photos of the property. The photos were shared on screen. Sean Angelini stated the system proposed would offset 99% of the homeowner's electric use. He is very experienced in Solar Panel installation. Commissioner Troy Simmons stated the panels should not be visible from the street view. Ms. Long-Temple stated the panels will not be visible from across the street. The neighboring homes would also conceal the panels. Ms. Long-Temple stated the Solar Panels are necessary as it will aid with her medical conditions. Commissioner Troy Simmons suggested relocating the four panels on the front of the house to the back of the house. Mr. Angelini stated the Fire Code setbacks have to be met. Ms. Long-Temple stated the relocating of the panels would be difficult because of the code. The roof has a slant it may be a cause for a concern. Commissioner Troy Simmons stated the owner agreed to do a composite roof but he has completed an asphalt shingle roof. The owner told to Commissioner Simmons he could not afford the composite and inquired about another home which had done the same thing. Some of the shingles are even nailed on. One of the things that the HPC is up against is that some of the contractors are not familiar with some of the work that can be done to preserve the Historic look. Janine Bauer, Esq. will write a letter of violation for the green tile roof and 596 Berkeley Ave. Commissioner Karen Wells inquired about the process when residents apply for permits. She also asked if the Building Department distributes the HPC Guidelines which that is not their responsibility.
