TITLE: **A RESOLUTION AUTHORIZING A CONTRACT WITH ENTERPRISE FM TRUST, 1550 ROUTE 23 NORTH, SUITE 101, WAYNE, NEW JERSEY 07470 TO LEASE VEHICLES IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$575,000) OVER A TERM OF THREE (3) YEARS FROM JANUARY 1, 2023 TO DECEMBER 31, 2026**

WHEREAS, there exists a need for the City of Orange Township to lease, regularly upgrade and maintain vehicles for its fleet in Police Department, Fire Department, Department of Public Works, Code Enforcement, Community Services and other essential (on 24-hour call) job titles; and

WHEREAS, the City of Orange Township was authorized to enter into the Sourcewell Cooperative Purchasing System through Resolution 365-2022 on September 6, 2022; and

WHEREAS, the City Administration has conducted an exhaustive evaluation of the current state/condition of the fleet, including a needs assessment and a cost assessment; and

WHEREAS, the Administration has determined that continuing a fleet leasing program is more operationally efficient and will create budgetary savings, while maintaining a current fleet; and

WHEREAS, the City will achieve reduced maintenance, fuel, and insurance costs; and

WHEREAS, the needs include police, fire, public works, code enforcement, community services and essential employee vehicles; and

WHEREAS, it is recommended to this Municipal Council that a contract be approved under the terms and conditions as stated in the attached contract to lease vehicles for its fleet; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto, certifying that funds will be available for this purpose in Account No. _____, contingent upon Council approval and inclusion of said item in the Temporary Budget and adopted 2023 Budget, there will be sufficient funds to contract with Enterprise FM Trust and contingent upon the City meeting the requirements pursuant to Local Finance Notice 2012-10 related to national cooperative contracting; and

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF ORANGE TOWNSHIP, does hereby approve the awarding to Enterprise FM Trust, 1550 Route 23 North, Suite 101, Wayne, New Jersey 07470 for the purpose of leasing, upgrading, and maintaining vehicles for the City's fleet in its Police Department, Fire Department, Department of Public Works, Code Enforcement, Community Services and other (on-24-hour call) job titles.
