A RESOLUTION AMENDING RESOLUTION 429-2022 ENTITLED "A RESOLUTION AUTHORIZING THE AWARDING OF A CONTRACT FOR THE 2022 NJDOT LTPF ROADWAY IMPROVEMENTS TO CIFELLI & SON GENERAL CONTRACTING, 81 FRANKLIN AVENUE, NUTLEY, NEW JERSEY 07110 IN THE AMOUNT NOT TO EXCEED \$1,196,975.35".

WHEREAS, pursuant to Resolution #429-2022, adopted November 1, 2022, the City Council did authorize the Mayor and the City Clerk to execute an agreement with Cifelli & Son General Contracting for the 2022 NJDOT LTPF Roadway Improvements to Ridge Court (between White St to Dead End), Waverly Place (between Scotland Rd to Dead End), Berkeley Ave (between Tremont Ave to South Orange Border), Mosswood Ave (between Heywood Ave to Tremont Ave), Haxtun Avenue (between Heywood Ave to Tremont Ave), Tremont Avenue (between Berkeley Ave to Haxtun Ave) and Park Place (between Park Ave to East Orange Border); and

WHEREAS, Resolution #429-2022 was adopted on November 1, 2022 to award the contract. However, the tabulation spreadsheet had incorrect amounts for the following:

WHEREAS, the City of Orange Township did duly advertise on September 29, 2022 for public bids for the 2022 NJDOT LTPF Roadway Improvements to Ridge Court (between White St to Dead End), Waverly Place (between Scotland Rd to Dead End), Berkeley Ave (between Tremont Ave to South Orange Border), Mosswood Ave (between Heywood Ave to Tremont Ave), Haxtun Avenue (between Heywood Ave to Tremont Ave), Tremont Avenue (between Berkeley Ave to Haxtun Ave) and Park Place (between Park Ave to East Orange Border); and

WHEREAS, on October 13, 2022 the City of Orange Township received eight (8) public bids pursuant to the plans and specifications furnished prospective bidders, from the following:

WHEREAS, bid submitted by Reivax Contracting Corp was revealed mathematical errors and is therefore disqualified; and

WHEREAS, it is the recommendation of the Consulting Engineer that the contracted be awarded; and

WHEREAS, the Director of Public Works & Engineering did duly examine and study each and every bid submitted and recommends that a contract be awarded to the lowest responsible bidder, pursuant to said specifications and said limits, by the following company:

WHEREAS, the aforementioned Cifelli & Son General Construction, Inc. has furnished the City of Orange Township, with a Ten Percent (10%) Stockholder Affidavit in accordance with Assembly Bill OCR-A-22; and,


WHEREAS, Cifelli & Son General Construction, Inc. has completed and submitted a Business Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the City in the previous one (1) year, except that the year 2005 is an exception to this requirement as the one year immediately preceding the effective date of the Law, as that term is defined below, and that the contract will prohibit Cifelli & Son General Construction, Inc. from making any reportable contributions throughout the term of the contract; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, copy of which is attached hereto and made a part hereof as it set forth in length herein, certifying that monies are available in Account No. G-02-00-559,001-023.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Orange Township, New Jersey that a contract be awarded for the 2022 NJDOT LTPF Roadway Improvements to Cifelli & Son General Construction, Inc., the aforesaid lowest responsive bidder, in the amount not to exceed \$1,196,975.35.

BE IT FURTHER RESOLVED, that the proper officers of the City of Orange Township, be and they are hereby authorized to return to the unsuccessful bidders, the certified checks, cashier's checks or bid bonds, evidencing their guarantee in accordance with the provisions of N.J.S.A. 40A:11-24.
