WHEREAS, a determination has been made that the aforementioned error needs to be corrected and that the do not exceed amount should be \$27,698.75; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has certified that the funds are available in Account No. C-04-05-000-000.

NOW, THEREFORE, IT BE FURTHER RESOLVED that the Municipal Council of the City of Orange Township be and hereby authorizes additional funds to pay Bright View Engineering, LLC. to provide professional engineering construction administration services for the Highland Avenue Train Station Rehabilitation in the amount of \$2,632.50 making the new amount not to exceed \$\$27,698.75.
