All notices and other communications shall be sent by certified mail, return receipt requested, and shall be deemed to have been given when sent to the parties at their respective addresses as set forth above, unless a different address has been selected after the execution of this agreement and has been duly communicated to the party giving notice.

9. The City may terminate this Agreement upon three days notice with New Jersey Door Works, LLC. In the event that this agreement is deemed to be terminated, the City shall pay New Jersey Door Works, LLC for those services provided as of the effective date of termination.
