WHEREAS, Lasenberry, Kevin is an honorably discharged veteran who has been certified as a 100% totally disabled veteran entitled to exemption from real estate taxes pursuant to N.J.S.A. 54:4-3.30 et seq; and

WHEREAS, Lasenberry, Kevin has been granted 100% exemption from real estate taxes from December 3, 2022; and

WHEREAS, Corelogic paid 4th quarter 2022 taxes in the amount of \$1,076.76 and 1st quarter 2023 taxes in the amount of \$3,256.20 for a total of \$4,332.96; and

WHEREAS, the Tax Collector has advised that Corelogic is due a refund in the amount of \$4,332.96; and

BE IT RESOLVED that the Tax Assessor and Tax Collector adjust their records to reflect the aforementioned grant of exemption; and

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Orange Township, County of Essex, State of New Jersey, hereby authorize the Tax Collector to refund Corelogic in the total amount of \$4,332.96 and to cancel any future tax billings.
