# **Police Department**

Police Chief Vincent Vitiello thanked the City of Orange, all the departments, and the Fire Chief for supporting the Police Department during this difficult time. He was appreciative of the well wishes. Officers were assigned to support the Autism Walk this past weekend. He wanted to acknowledge the men and women of the Police Department for staying focused on a possible threat even though they were going through a hard time. The lives of our children are the department's priority. Council President Tency A. Eason requested the Police Department be prepared for motor bikes this summer. Police Chief Vincent Vitiello will investigate legislation in other cities. Councilmember Weldon M. Montague, III inquired if a license was required to operate the three wheelers and they are off road vehicles.

# Fire Department

Fire Chief Derrick Brown stated it was an honor for the Fire Department to support the Police Department through this difficult time. There were no major incidents on the fire side. Council President Tency A. Eason inquired about lithium batteries, how to legislate and enforce it. She asked him to work with the Business Administrator on this. Council Vice President Clifford R. Ross added that it should be noted that secondhand batteries should not be sold. Councilmember Kerry J. Coley stated there should be some communications surrounding blocking entry ways.

# **Planning Department**

Director Laquana Best thanked the residents who attended the Essex County Home Improvement Seminar. It was a successful turnout. The Orange Chamber of Commerce, the Township of Irvington, and the City of East Orange are preparing for the Third Annual Tri Community Commercial and Residential Development Seminar being held on Tuesday May 16, 2023, from 5:30-8:00pm. The first two years it was held in the City of Orange Township and this year it will be held in Irvington at the Parkway Office Campus on Union Ave. The Flier will be sent to the Clerk's Office and posted on the website. The admission is \$10 for Commerce Members and \$20 for guests. Council Vice President Clifford R. Ross stated the new development looks good and he requests a tour prior to the ribbon cutting which should be the beginning of June. He saw information on the website about a Landlord Tenant Informational Seminar being held at the Newark Public Library on Thursday, May 4<sup>th</sup> from 6-7:30pm. Council President Tency A. Eason requested a similiar seminar be scheduled in the City of Orange Township as well.

### **Finance Department**

Chief Financial Officer Nile Clements stated Ordinance 17-2023 is on first reading on tonight's agenda. This is a two-part Ordinance to exceed the Municipal Budget Appropriation limit which is normally 2.5% and extend it to 3.5%. The second part is to establish a Cap Bank, so whatever percentage increase that is not used in this year's budget, we will have the ability to utilize in the succeeding year. The Finance team intends to have the budget ready at the next Council Meeting.

## **Tax Collector**

Director Paula Ferreira stated the seconded quarter taxes are due on May 1<sup>st</sup> and they have until May 10<sup>th</sup> to pay without interest. Council President Tency A. Eason requested an instructional program for residents on how to complete the application for the Tax Freeze Program.

### **Public Works**

Director Marty Mayes thanked all who attended the Spring Shredding Event. The Fall Shredding Event will be held on October 14<sup>th</sup>. Military Park groundbreaking will be held on May 27<sup>th</sup> at 5pm. Colgate Pool is complete and there will be a ceremony on May 16<sup>th</sup> from 2-6pm. County Executive Joseph DiVincenzo will speak and there will be a barbeque. The department is preparing to begin paving season beginning with Park Place then Waverly Place.

Bids for Metcalf Park Basketball Court have been received and the paperwork is in process. This winter did not call for the city to use brine. The brine tank is being installed and we will be prepared for the next winter. The final plans for Ropes Playground are underway. Councilmember Weldon M. Montague, III inquired about Metcalf Park which is undergoing a rehabilitation and it will be done on Friday. He also inquired about parking on Park Avenue and having the street cleaning done earlier and Director Marty Mayes will speak with the Business Administrator. There was meeting today concerning the gas tank and the final draft will be in next week. Council Vice President Clifford R. Ross inquired about the street sweepers and Director Marty Mayes is looking into buying or leasing new machines as they are encountering a lot of breakdowns. He also asked about the bids on the Garbage Contractor which it is in review. Council Vice President Clifford R. Ross stated Central Playground looks good and there will be more work done there. Saturday, April 22<sup>nd</sup> at 340 Central Avenue there will be a Cherry Blossom Event with refreshments and House Music. Councilmember Kerry J. Coley inquired about using Shauger Group for street cleaning which Director Mayes will discuss with the Business Administrator.

# Law Department

Attorney Gracia R. Montilus, Esq. stated there are no legal updates at this time but he is prepared to do an update with the Governing Body.

## Tax Assessor

Director Chris Murray thanked all who sent condolences and positive energy for the passing of his father. The County Tax Appeals for 2023 had 151 appeals filed which is down 50 from the prior year. Of the 151 there 24 pending and 82 are habitual filers.

Business Administrator Chris Hartwyk answered a question for Councilmember Kerry J. Coley which they are renegotiating a redevelopment agreement. Once finalized it will be presented to Council. He anticipates the agreements will be done in July.

## **COMMUNICATIONS AND PETITIONS**

The Planning Board of the City of Orange Township will hold a special, virtual public hearing on an application filed for Preliminary & Final Major Site Plan approval for several buildings located on South Day Street and Reock Street. # CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The Deputy City Clerk announced that a "SPECIAL NOTICE: Please be apprised anyone wishing to discuss Agenda or General Items shall be allowed to participate in this portion of the Council Meeting via the audio call in number and video conferencing platform by stating their name and address when directed to do so by the Council President. All public comments submitted though electronic mail or written letter before the meeting shall be read aloud by the City Clerk. The City Council reserves the right to respond to not respond during the meeting to any citizen's questions or comments. If the Council wishes to address any comments, it shall be done during the remote public meeting.

Aisha Samuel of 401 Highland Terrace stated the corner of Tremont and Center needs lighting for all turns in all directions. Highland Terrace needs to be repaved and needs a sign and speed bump. She still doesn't have a sign for her driveway. Forrest Street School needs paving and speed bumps. Director Mayes stated the signs have not arrived, but he asked for a rush job and the "Watch for kids" sign will be ordered. Council President Tency A. Eason stated speed bumps can't be added on every street and Director Marty Mayes will get a read out on rumble strips. West Orange has applied to repair South Valley Road.

James H. Ward, III thanked the Orange Police Department and he sent a letter of thanks to the department for their valiant work and for the personal loss suffered. He spoke to Ordinance 7-2023, bond ordinance for our PFAS water treatment. There was two billion dollars made available in the bi-partisan infrastructure bill that passed this past February. There was specific carve outs for PFAS and drinking water. He asked if the City of Orange is

accessing any of these funds to help pay for this work. There were specific carve outs for clean water projects in small, rural and disadvantaged communities, we probably qualify for two of those and we need to reach out to try and secure these funds. We need to know what are the levels PFAS that are in our water system and we need a presentation from the Water Department in particular. There are three technologies on how to mitigate PFAS and they each have significantly different cost. There is an item asking for \$10,000,000.00, which we will be paying for generations. We need to identify what the problem is, what is the proposed solution, and how much will it cost. Business Administrator Chris Hartwyk stated the City made application through the Appropriation Gant process and have not heard back yet. A substantial portion of the \$2,000,000,000.00 is being funneled through the state. It is being used through the Infrastructure I Bank and Water Bank. We have made application for this \$10,000,000.00 through the I Bank as well. He also stated that he would obtain the PFAS levels but through the temporary treatment process it is zero.

Stacey Gibbs of 340 Gist Place had questions about the Covid vaccines and if they were appropriate for her four year old. She is concerned about the past activities at the high school and how we make it safer because her daughter had a gun pointed at her face. She has noticed Central Park being fixed and the completion of Colgate Pool, but the playground is not being fixed as she knows there was a grant received. She is concerned about this because she has a daughter with autism. The gutters on Gist place need to be cleaned. Health Officer Vincent DeFilippo directed Ms. Gibbs to call him at 973-789-4013. There are two locations that administer vaccines, Turtle Back Zoo and the City of East Orange has a site. Director Marty Mayes stated Colgate Park plans are in the making and he will check the gutters on Gist Place. Council President Tency A. Eason directed Ms. Gibbs to reach out to the Superintendent of Schools in regards to the safety of the schools. Director Mayes gave Ms. Gibbs his number to discuss parks off line 973-885-1921.

**Douglas Farrand works at 47 Cleveland Street** extended an invitation to the 7<sup>th</sup> Annual City Music Festival, May 12<sup>th</sup>-14<sup>th</sup>. There are three locations and he will share the flier via e-mail. The festival locations are as follows: May 12<sup>th</sup> Central Avenue – Sarah's Cafe, May 13<sup>th</sup> Essex Avenue – Inner City Cafe, and May 14<sup>th</sup> in the valley – City Kitchen. There is an event on May 9<sup>th</sup>, 3pm at the Walter G. Senior Housing Complex in remembrance of Slide Hampton a globally recognized jazz artist who lived in Orange the last 25 years of his life. He is a Member and Board President of First Unitarian Church located at 35 Cleveland Street. The congregation has concerns with the Ordinance for the Peek Cleveland Street Open Renewal Development when it comes to tax abatement. Council President Tency A. Eason stated the ordinance will be postponed.

Joseph Seneca of 420 Minton Place wanted to complain about the ice-cream truck that was referenced by Council Vice President Clifford R. Ross. He thanked Police Chief Vincent Vitiello for be vigilant with loud noise in the neighborhood. He requested yellow lines near his home because people are constantly parking in his driveway. Minton Place is narrow and has speeding issues, and he request speed bumps. Joyce and Frankfort Street need to be repaved. He called the water department and spoke with Tom C. and inquired why he has to pay a fee when paying his bill electronically. Business Administrator Chris Hartwyk stated the transaction fee is associated with the credit card payments and Council Tency A. Eason directed him to call the Business Administrator to get further details.

Volora Howell of 483 Mountainview Avenue inquired about the honorarium because she understands there is legislation on tonight's agenda to amend the requirements. Her daughter was to be honored with a Street naming. Council President Tency A. Eason explained there is legislation on First Reading, and then it has to go to Second Reading but it is being working on.

Winsome Wynter of 236 Henry Street inquired about the Orange Memorial Hospital site and if there are any plans. Business Administrator Chris Hartwyk stated there is a Resolution on tonight's agenda asking for a memorandum of understanding – a joint venture to change hands. The current ownership is one of the road blocks. The view is to clean it up and put up new structures. Ms. Wynter will reach out to the Business Administrator off line.

Richard Martha of 740 McLaughlin Place wanted to thank Director Marty Mayes who came to his block to discuss concerns he raised at the past Council Meeting and erected a No Parking Sign. He wanted to discuss violators and how he should report the violations. Argyle and Scotland Road is a dangerous intersection and a pole should be put there. Council President Tency A. Eason stated the Parking Authority is not up and running yet, so he should contact the Police Department. She will request a Police ride through to check.

Joe Watson of 156 North Essex Avenue inquired about the process for reconsideration on the Cannabis Ordinance as it could be a great source of income. Council President Tency A. Eason stated she could not commit on this as it is in litigation.

Anita White of 465 Lawn Ridge Road stated the city is going through a lot of redevelopment and wanted to know what the status of the New Jersey Transit building off of Lincoln which is off the train track – it is an eye sore. Business Administrator Chris Hartwyk stated this is a construction epot yard for New Jersey Transit where they store construction and power equipment. He has had multiple conversations with New Jersey Transit about the conditions of the property. The City is not allowed to fine New Jersey Transit as they are a state agency. We continue to reach out to State Legislators trying to get this resolved.
