TITLE: AN ORDINANCE TO AMEND CHAPTER 88, ENTITLED "FEES" OF THE CODE OF THE CITY OF ORANGE TOWNSHIP.

WHEREAS, the City of Orange Township Division of Recreation provides a plethora of recreational programs that service the City's youth, adult and senior citizen population; and

WHEREAS, the City not Only provides the physical facilities for programs to place and nourish, but in addition thereto, provide personnel to assist the aforestated participants as well as equipment and uniforms; and,

WHEREAS, the City has determined that a commitment fee for registration and participation in certain activities may assist in covering just a small fraction of costs expended and enhance the services delivered.

WHEREAS, N.J.S.A 40:48-1, et seq., of the New Jersey Statues authorizes the City to manage, regulate and control the City's finances;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ORANGE TOWNSHIP that chapter 88, "Fees", of the Code of the City of Orange Township is hereby amended and supplemented as follows:

Section 1. General Registration

- A. Recreation registration fees and charges shall apply for participation in programs sponsored by the City of Orange Township Recreation Department. The recreation registration fees shall permit registrant to enroll in any recreation activity or program offered to that person by the city.
- B. In the event of a demonstration of hardship, the registration fee may be subject to reduction or waiver.
- C. A late fee of twenty dollars (\$20.00) will be assessed, in addition to the registration fee(s), for registration occurring more than thirty (30) days after the commencement of open registration.
- D. The City of Orange Township reserves the right to assess additional event fees for special programs that may be implemented in the future, including but not limited to the Summer Youth Games, Summer Camp and out of state travel tournaments.
