NOW, THEREFORE, BE IT BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, ESSEX COUNTY, NEW JERSEY as follows:

Section 1 Amendment to Municipal Code.

Part II, Chapter 98 (Food Handling Establishments), Article I (Fees) of the Municipal Code, as amended, is hereby further amended as follows:

§ 98-4 Fees

Bakery, full-service	\$ 100 <u>125.00</u>
Bakery, specialty	\$ 75 <u>100.00</u>
Candy counters	\$ 50 <u>75.00</u>

Frozen dessert, seating	\$ 75 <u>100.00</u>

Meat or fish market	\$ 75 <u>100.00</u>

§ 98-14 Permit and License Fees

- a) Permit Fee: \$40.00
- b) License Fee: ~~\$30~~ 40.00 for one machine per year and ~~\$15~~ 20.00 for each additional machine per year with a maximum of \$250.00 dollars for any number for machines.

TITLE: **AN ORDINANCE TO AMEND ORDINANCE #12-2010 CHAPTER 98 FOOD HANDLING ESTABLISHMENTS ADOPTED AUGUST 4, 2010 AND AMENDED ORDINANCE #21-2012 ADOPTED SEPTEMBER 4, 2012.**

WHEREAS, the City of Orange Township presently has an ordinance establishing procedures and fees for food handling; and

WHEREAS, this amendment shall include additional establishments; and

WHEREAS, all fees listed herein shall be collected by the Department of Health.

NOW, THEREFORE, BE IT ORDAINED that the Municipal Council of the City of Orange Township be and hereby amends Chapter #98 to include the following:

ARTICLE 1

98-4. Fees.

The yearly license fees for retail food establishments shall be as follows:

- A. Bakery specialty: Seventy-five dollars (\$75.)
- B. Bakery full service: One hundred dollars (\$100.)
- C. Candy counters: Fifty dollars (\$50.)
- D. Catering, off premises only: One hundred twenty-five dollars (\$125.)
- E. Delicatessen-grocery, no seating: Seventy-five dollars (\$75.)
Delicatessen-grocery: One hundred dollars (\$100.)
- F. Frozen dessert, no seating: Fifty dollars (\$50.)
- G. Frozen dessert, seating: Seventy-five dollars (\$75.)
- H. Health care facility, w/bed capacity up to 40: One hundred twenty-five dollars (\$125.)
- I. Health care facility, w/bed capacity over 40: Three hundred dollars (\$300.)
- J. Health care facility, nonprofit: Two hundred fifty dollars (\$250.)
- K. Meat or fish market: Seventy-five dollars (\$75.)
- L. Mobile truck (food peddlers), Sealed packaged goods only: ~~One hundred dollars (\$100.)~~ One hundred and fifty dollars (\$150)

- M. Packaged goods store/gas stations: Seventy-five dollars (\$75.)
- N. Manufacturing plant and commercial cafeterias: ~~One hundred twenty five dollars (\$125.)~~
- a. with over 20,000 square feet: Four Hundred Dollars (\$400.00)
- b. with 15,000 square feet: Three Hundred Dollars (\$300.00)
- c. with 10,000 square feet: Two Hundred Dollars (\$200.00)
- O. Restaurant, luncheonette, hotel, country club or banquet house with a seating capacity of 0 — 50 persons: One hundred dollars (\$100.)
- P. Restaurant, luncheonette or banquet house with a seating capacity of 51 to 100 persons: One hundred fifty dollars (\$150.)
- Q. Restaurant, luncheonette or banquet house with a seating capacity of 101 to 150 persons: Two hundred dollars (\$200.)
- R. Restaurant, luncheonette or banquet house with a seating capacity over 200 persons: Three hundred dollars (\$300.)
- S. Schools and nursery schools with food, profit: One hundred dollars (\$100.)
- T. Schools and nursery schools with food, nonprofit: Fifty dollars (\$50.)
- U. Snack bar: Seventy-five dollars (\$75.)
- V. Supermarket with up to 20,000 square feet: One hundred fifty dollars (\$150.)
- W. Supermarket with over 20,000 square feet: Two hundred fifty dollars (\$250.)
- X. Tavern or liquor store without food service: ~~Fifty dollars (\$50.)~~ One hundred dollars (\$100)
- Tavern or liquor store with food service: ~~One hundred dollars (\$100.)~~ One hundred and Fifty dollars (\$150)


- Y. Dispensing of packaged ice: Fifty dollars (\$50.)
- Z. Reserved, Commercial/Rental Kitchens: Two-hundred Dollars

- AA. Adult daycare: One hundred dollars
