MATTERS FOR DISCUSSION

COVID Update

Health Officer Vincent DeFilippo stated CDC has stopped reporting Covid-19 numbers. Covid-19 death totals for May 1st – May 25th were as follows: ages 0-4 years old there were none, ages 5-17 years old there was one, ages 18-29 years old there were none, ages 30-49 years old there were nine, ages 50-64 years old there were 39, and ages 65-79 years old there were 158. There were 518 positive cases during this time. It is tick season and there has been 2,123 people who have been bitten by ticks in New Jersey and last year there were 5,900 tick bites. He spoke about the air quality due to the fires in Canada. At 9:30 the air index quality was at 150 which is unhealthy but sensitive, at 4:00 the air index quality was at 407 which is hazardous and unhealthy. It is advised that residents stay inside and if outside, one should wear N95 mask. Do not burn candles or use vacuum cleaners because it stirs up dust particles. Keep air conditioner filters clean. This is anticipated to last until Friday. Council Vice President Clifford R. Ross inquired about tick bites. Health Officer DeFilippo suggested wearing long socks and keeping the skin covered. A tick bite looks like a bullseye and if you see this you should visit your primary care physician. Council President Tency A. Eason stated Ocean County is also experiencing fires. Councilmember Kerry J. Coley inquired about the Free Rabies shot event which the city does this event in January and February. East Orange had an event last week and if a resident is interested they should reach out to the Health Department. Councilmember Weldon M. Montague, III stated there are vendors on Freeway Drive and this should be addressed. Council Vice President Clifford R. Ross spoke about a task force to deal with this issue.

The resolutions and ordinances to be presented at tonight's meeting are listed on the attached Regular Meeting Agenda. If any Council Member wishes to discuss any resolution or ordinance, it may be discussed at this time.

Council President Tency A. Eason stated there was not a Finance Meeting this evening because there was a Budget Hearing. Councilmembers should bring up there concerns about proposed legislation at this time.
