AN ORDINANCE OF THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, ESSEX COUNTY, NEW JERSEY, AMENDING CHAPTER 88 OF THE MUNIPAL CODE OF THE CITY OF ORANGE TOWNSHIP, ENTITLED "FEES" TO REFLECT UPDATED POLICE DEPARTMENT FEES.

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, ESSEX COUNTY, NEW JERSEY as follows:

Section 1 Amendment to Municipal Code.

Part II, Chapter 88 (Fees), Article I (Fees Derived From Code Provisions) of the Municipal Code, as amended, is hereby further amended as follows:

§ 88-1 Schedule of fees.

In person at police headquarters per page	\$ 0.50 3.00
Photostat of a report other than an accident	\$2.00
Taking fingerprints of canvassers, solicitors, applicants for gun permits and any other individuals whose, by virtue of their employment, profession or occupation, fingerprints are required	\$ 15.00 20.00
Issuance of permit to purchase a pistol or revolver	\$ 2.00 -25.00
Issuance of permit to purchase firearms	\$ 5.00 -50.00

Section 3 Conflicts and Inconsistencies.

All other Ordinances and parts of Ordinances that conflict or are inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency.

Section 4 Effective Date.

Following final passage, this Ordinance shall take effect upon the expiration of 20 days after publication, unless otherwise provided by the Municipal Council.
