TITLE: AN ORDINANCE OF THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, ESSEX COUNTY, NEW JERSEY, AMENDING CHAPTER 88 OF THE MUNICIPAL CODE OF THE CITY OF ORANGE TOWNSHIP, ENTITLED "FEES" TO REFLECT UPDATED POLICE DEPARTMENT FEES.

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, ESSEX COUNTY, NEW JERSEY as follows:

Section 1 Amendment to Municipal Code.

Part II, Chapter 88 (Fees), Article I (Fees Derived From Code Provisions) of the Municipal Code, as amended, is hereby further amended as follows:

§ 88-1 Schedule of fees.

Chapter 26, Police Department

Copies of reports which are noncriminal in nature	\$2.0010.00
Search fee in cases where a review of a record is desired	\$2.0010.00
Viewing photographs of accident scenes	\$2.0010.00
Copies of photographs, each	\$7.5015.00
Photostat of an accident report:	
By mail <u>per report</u>	\$5.00 10.00
In person at police headquarters <u>per page</u>	\$0.50 3.00
Photostat of a report other than an accident	\$2.00
Taking fingerprints of canvassers, solicitors, applicants for gun permits and any other individuals whose, by virtue of their employment, profession or occupation, fingerprints are required	\$15.00 20.00
Issuance of permit to purchase a pistol or revolver	\$2.00 25.00
Issuance of permit to purchase firearms	\$5.00 50.00

Section 2 Severability of Ordinance Provisions.

Each Section of this Ordinance is an independent Section and any part hereof found unconstitutional, void or ineffective for any cause shall not affect the validity or constitutionality of any other parts hereof.

Section 3 Conflicts and Inconsistencies.

All other Ordinances and parts of Ordinances that conflict or are inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency.

Section 4 Effective Date.

Following final passage, this Ordinance shall take effect upon the expiration of 20 days after publication, unless otherwise provided by the Municipal Council.

TITLE: AN ORDINANCE TO AMEND THE CODE OF THE CITY OF ORANGE TOWNSHIP, CHAPTER 88, ENTITLED "FEES," TO INCREASE CERTAIN FEES TO CONFORM WITH STATE STATUTE.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ORANGE TOWNSHIP THAT:

Section 1. Chapter 88-1 "Schedule of fees" be amended in part to read as follows:


Chapter 26, Police Department

- Copies of reports which are non-criminal in nature.....\$2.00
- Search fee in cases where a review of a record is desired.....\$2.00
- Viewing photographs of accident scenes.....\$2.00
- Copies of photographs, each.....\$7.50
- Photostat of an accident report:
 - By mail.....\$5.00
 - In person at Police headquarters.....\$.50
- Photostat of a report other than an accident.....\$2.00
- Taking fingerprints of canvassers, solicitors, applicants for gun permits and any other individuals whose, by virtue of their employment, profession or occupation, fingerprints are required.....\$15.00
- Issuance of permit to purchase a pistol or revolver.....\$2.00
- Issuance of permit to purchase of firearms.....\$5.00

Section 2. Any ordinance inconsistent with this ordinance is repealed but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final passage, approval and publication according to law.
