**NOW THEREFORE BE IT ORDAINED** by the City Council of the City of Orange Township that Chapter 200 of the Code is amended and supplemented as follows:

**Section 1:**

Chapter 200, Section 200-10.2, Ordinance 27-2020 of the Code of the City of Orange Township be amended to include one (1) additional street as follows:

<u>Street</u>	<u>Side</u>	<u>Hours</u>	<u>Location</u>
Pierson Street	Both	7:00 p.m. – 6:00 a.m.	The Entire Street

Motor vehicles with the decal prominently displayed in the rear window shall be entitled to be parked without limitation as to hours parked, between the hours of 4:00 p.m. – 7:00 a.m. on the streets or portions of streets within Residential Permit Parking Zone A.

**Section 2:**

Any Ordinance inconsistent with this Ordinance is repealed, but only to the extent of such inconsistencies.

**Section 3:**

This Ordinance shall take effect upon final passage, approval and publication according to law.

**Purpose:** To amend Section 200-10.2 – residential **parking** zone to include an additional street.

**TITLE:**

**AN ORDINANCE TO AMEND THE CODE OF THE CITY OF ORANGE TOWNSHIP, CHAPTER 200, ENTITLED "VEHICLES AND TRAFFIC", SECTION 200-10.2, RESIDENTIAL PERMIT. (New Street)**

WHEREAS, the City Council of the City of Orange Township deems it necessary to allow residential permit parking on certain streets during certain hours.

NOW, THEREFORE BE IT ORDAINED that the City Council of the City of Orange Township that Chapter 200 of the Code is amended and supplemented as follows:

**SECTION 1.**

a) **§ 200-10.2. Residential Permit Parking Zone A.**

Chapter 200, Section 200-10.2 of the Code of the City of Orange Township be amended to include one (1) additional street as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Hours</u>	<u>Location</u>
<u>New Street</u>	<u>Both</u>	<u>7:00 p.m. – 6:00 a.m.</u>	<u>Park Street and North Center Street</u>

Motor vehicles with the decal prominently displayed in the rear window shall be entitled to be parked without limitation as to hours parked, between the hours of 7:00 p.m. – 6:00 a.m. on the streets or portions of streets within Residential Parking Permit Zone A.

**SECTION 2. Severability of Ordinance Provisions**

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity of constitutionality of any other sections or parts thereof.

**SECTION 3. Conflict of Other Ordinance Provisions**

That all ordinances and parts of ordinances and conflicts that are inconsistent with this ordinance are hereby repealed but only to the extent of such conflict or inconsistency.

**SECTION 4. Effective Date of Ordinance Provisions**

That this ordinance shall take effect upon final passage upon expiration of twenty (20) days following publication unless otherwise provided.
