A RESOLUTION AUTHORIZING THE EXTENSION OF THE AGREEMENT FOR THE REMOVAL OF SOLID WASTE AND RECYCLING SERVICES WITH JOSEPH SMENTKOWSKI, INC., 160 JAMES AVENUE, JERSEY CITY, NEW JERSEY 07306 FOR AN ADDITIONAL NINETY DAY (90) PERIOD COMMENCING SEPTEMBER 1, 2023 THROUGH NOVEMBER 30, 2023 IN THE AMOUNT NOT TO EXCEED \$345,000.00.

WHEREAS, the extension of the contract between the City of Orange Township and Joseph Smentkowski, Inc., 160 James Avenue, Jersey City, New Jersey 07306, for Solid Waste and Recycling Services expires on August 31, 2023; and

WHEREAS, the provision of Solid Waste and Recycling Services is a service that must be bid under the Local Public Contracts Law; and

WHEREAS, the current vendor, Joseph Smentkowski, Inc. has agreed to obtain an extension; and

WHEREAS, it is anticipated that an additional ninety day period will be required in order to properly award the Solid Waste and Recycling Services; and

WHEREAS, as a result, the Municipal Council of the City of Orange Township authorized the execution and delivery of an extended contract with Joseph Smentkowski, Inc. and such contract is authorized by N.J.S.A., 40A:11-6; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto, certifying that funds will be available for this purpose in Account No. 3-01-26-305-000-528, contingent upon Council approval and inclusion of said item in the Temporary Budget and adopted 2023 Budget, there will be sufficient funds to contract with Joseph Smentkowski, Inc.

NOW, THEREFORE, BE IT RESOLVED, that the Municipal Council of the City of Orange Township does authorize the extension of the contract with Joseph Smentkowski, Inc. for the Solid Waste and Recycling Services for the City of Orange Township, in the amount not to exceed \$345,000.00 for an additional ninety days commencing September 1, 2023 through November 30, 2023.

ADDENDUM AGREEMENT

This Addendum Agreement, made and entered into this **16th** day of **May 2023**, between the City of Orange Township and **Joseph Smentkowski, Inc., 160 James Avenue, Jersey City, New Jersey 07306.**

WHEREAS, the City Council of the City of Orange Township has, by **Resolution #____-2023** dated _____, **2023** authorized **Joseph Smentkowski, Inc., for the continuation of the solid waste and recycling services in the City of Orange Township.**

WHEREAS, continuation of the solid waste and recycling services are required for an additional ninety day period;

NOW, THEREFORE, BE IT AGREED by and between the parties, for the mutual covenants set forth herein below:

1. The amount of the services shall not exceed in the amount of \$345,000.00.
2. This addendum agreement shall be effective commencing on September 1, 2023 through November 30, 2023 approved by resolution of the City Council of the City of Orange Township.
3. This addendum agreement shall not be assigned nor shall any duties under this agreement be delegated by **Joseph Smentkowski, Inc.** without prior written consent of the City.
4. The City may terminate this Agreement upon three days notice to **Joseph Smentkowski, Inc.** In the event that this agreement is deemed to be terminated, the City shall pay **Joseph Smentkowski, Inc.** for those services and supplies provided as of the effective date of termination.
