WHEREAS, the extension of the contract between the City of Orange Township and Shauger Property Services, 429 Dodd Street, East Orange, New Jersey 07017, for "On Call" Snow Plowing Services expires on December 31, 2023; and

WHEREAS, the provision of "On Call" Snow Plowing Services is a service that must be bid under the Local Public Contracts Law; and

WHEREAS, the current vendor, Shauger Property Services, Inc., has agreed to obtain an extension; and

WHEREAS, it is anticipated that an additional ninety day period will be required in order to properly award the "On Call" Snow Plowing Services; and

WHEREAS, as a result, the Municipal Council of the City of Orange Township authorized the execution and delivery of an extended contract with Shauger Property Services, Inc. and such contract is authorized by N.J.S.A., 40A:11-6; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto, certifying that funds will be available for this purpose in Account No. 4-01-26-292-000-528, contingent upon Council approval and inclusion of said item in the Temporary Budget and adopted 2024 Budget, there will be sufficient funds to contract with Shauger Property Services, Inc.

NOW, THEREFORE, BE IT RESOLVED, that the Municipal Council of the City of Orange Township does authorize the extension of the contract with Shauger Property Services, Inc. for the "On Call" Snow Plowing Services for the City of Orange Township, in the amount not to exceed \$30,000.00 for an additional ninety days commencing January 1, 2024 through March 31, 2024.
