TITLE: AN ORDINANCE TO AMEND CHAPTER §200-32, CHAPTER §200-33, AND CHAPTER §200-38 OF THE CITY OF ORANGE TOWNSHIP CODE

WHEREAS, it is the policy of the City of Orange Township to regulate, in a manner consistent with the interests of the citizens of the City of Orange Township, the location of One-Way Streets in the City;

WHEREAS, Representatives from Remington & Vernick Engineers performed a site visit on North Jefferson Street to investigate a request to convert North Jefferson Street to a One-Way Street;

WHEREAS, Representatives from Remington & Vernick performed their on-site visit and are recommending North Jefferson Street be converted into a One-Way Street;

WHEREAS, the below changes will allow for additional parking and help to alleviate congestion;

NOW, THEREFORE, BE IT ORDAINED, that Chapter §200-32 of the Code of the City of Orange Township be amended and supplemented as follows; and

NOW, THEREFORE, BE IT ORDAINED, that Chapter §200-33 of the Code of the City of Orange Township be amended and supplemented as follows; and

NOW, THEREFORE, BE IT ORDAINED, that Chapter §200-38 of the Code of the City of Orange Township be amended and supplemented as follows.

North Jefferson Street	West	From 950 feet South of the intersection of North Jefferson Street & Main Street to the intersection of North Jefferson Street & White Street, Monday-Wednesday
