AGREEMENT

WHEREAS, the City of Orange Township wishes to retain a firm for the purpose of **purchasing hardware materials and supplies under the MCCPC#10** for the City of Orange Township, as specifically set forth in the attached proposal in the amount not to exceed **\$30,000.00 (\$20,000.00-Bldg/Grnds Division and \$10,000.00-Street Division)** for the period of **January 1, 2024 through June 30, 2024.**

WHEREAS, the City of Orange Township wishes to retain **Continental Hardware, Inc.** with offices located at **400 Delancy Street, Newark, New Jersey 07105.**

WHEREAS, this firm and the individuals of the firm are to be retained pursuant to the Agreement as specified under the **MCCPC#10**; and

WHEREAS, the City Council of the City of Orange Township has, by **Resolution No. ____-2024** dated _____, **2024**, authorizes **Continental Hardware, Inc.** for the purpose of **purchasing hardware materials and supplies**, as specified in the attached proposal.

NOW, THEREFORE, BE IT AGREED by and between the parties, for the mutual convenient set forth herein below:

1. **Continental Hardware, Inc.** is hereby contracted by the City of Orange Township to provide services as specified in the attached proposal.
2. This agreement shall be effective commencing on **January 1, 2024** and terminating on **June 30, 2024.**

3. This agreement shall not be assigned nor shall any duties under this agreement be delegated by **Continental Hardware, Inc.** without prior written consent of the City.
4. The validity of this agreement and its terms or provisions, as well as the rights and duties of the contracting parties, shall be governed by and construed in accordance with the laws of the State of New Jersey.
5. This agreement shall be binding on and inure to the benefit of the contracting parties and their respective heirs, executors, administrators, legal representatives, successors, and assigns when not expressly prohibited by this agreement.
6. In case any one or more of the provisions contained in this agreement shall for any reason be held to be invalid, illegal or unenforceable in any respect, the invalidity, illegality, or unenforceability shall not affect any other provision of it this agreement shall for any reason be held to be invalid, illegal, or unenforceable provision had never been contained in it.
7. This agreement constitutes the sole agreement of the contracting parties and supersedes any prior understandings or written or oral agreements between the parties respecting its subject matter.
8. All notices and other communications shall be sent by certified mail, return receipt requested, and shall be deemed to have been given when sent to the parties at their respective addresses as set forth above, unless a different address has been selected after the execution of this agreement and has been duly communicated to the party giving notice.
9. The City may terminate this Agreement upon three days notice with **Continental Hardware, Inc.** In the event that this agreement is deemed to be terminated, the City shall pay **Continental Hardware, Inc.** for those services

provided as of the effective date of termination. This agreement is final and cannot be amended, supplemented, changed or modified without said being in writing.
