TITLE: CAPITAL ORDINANCE APPROPRIATING \$630,000 FROM THE CAPITAL FUND BALANCE TO PAY FOR THE PURCHASE AND THE INSTALLATION OF A CITY-WIDE CAMERA SYSTEM, BY AND IN THE CITY OF ORANGE TOWNSHIP, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF ORANGE TOWNSHIP, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The capital purposes described in Section 2 of this capital ordinance are hereby authorized as general capital purposes to be undertaken by the City of Orange Township, in the County of Essex, State of New Jersey (the "City"). For the said improvements or purposes stated in Section 2 hereof, there is hereby appropriated the amount of \$630,000, which amount is now available in the Capital Fund Balance of the City from a previously adopted budget or budgets of the City.

- **SECTION 2.** (a) The improvements and purposes hereby authorized are for the purchase and installation of a City-wide camera system;
- (b) The above improvements and purposes set forth in Section 2(a) shall also include, but are not limited to, as applicable, all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto.

SECTION 3. The expenditure of \$630,000 from the Capital Fund Balance for the purposes set forth in Section 2 hereof is hereby authorized and approved.

SECTION 4. The City hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable, for the City. The capital or temporary capital budget, as applicable, of the City is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein

are inconsistent with the adopted capital or temporary capital budget of the City, a revised capital or temporary capital budget for the City has been filed with the Division of Local Government Services.

SECTION 5. This capital ordinance shall take effect twenty (20) days after the first publication of the notice of final adoption of this capital ordinance, as provided by the Local Bond Law.
