WHEREAS, the City of Orange Township received four (4) separate Grants to purchase bullet proof vests for our police department; and

WHEREAS, the grants awarded are as follows:

2023 JAG BODY ARMOR GRANT IN THE AMOUNT OF \$24,267;

2022 BULLET PROOF VESTS GRANT IN THE AMOUNT OF \$29,824.48;

2023 BULLET PROOF VESTS GRANT IN THE AMOUNT OF \$19,600; and

2023 STATE BODY ARMOR GRANT IN THE AMOUNT OF \$9,458.34

WHEREAS, Atlantic Uniform Co., is a state contract vendor with the ID of V00028267 for bullet proof vests and has performed in an effective and efficient manner; and

WHEREAS, these vests will help strengthen officer safety and protection; and

The New Jersey Department of Law and Public Safety is pleased to announce that your agency will receive \$9,458.34 under the State Fiscal Year 2023 State Body Armor Replacement Fund (BARF) Program. An electronic transfer of funds or an award check has been sent directly to your agency's Chief Financial Officer.

The State BARF Program assists all eligible law enforcement agencies to offset the costs of purchasing body vests for their officers. Although this is a five-year vest replacement program, program regulations encourage agencies to make every reasonable effort to expend their awards within one year of receipt.
