WHEREAS, the City Council did authorize the Mayor and the Municipal Clerk to execute an agreement with Picerno Giordano Construction, 200 Market Street, Kenilworth, New Jersey 07033 in the amount of One Million, Two Hundred Forty-Nine Thousand, Eight Hundred Forty-Four Dollars and Zero Cents, (\$1,249,844.00) as per Resolution #338-2023 for the Ropes Playground Improvements; and

WHEREAS, Change Order No. 1 is to change basketball goal from PX60XL to BA873U-BK in the amount of \$8,400.00; and (+0.7%); and

WHEREAS, Change Order No. 2 is for removal/pruning of two (2) additional trees within the park in the amount of \$2,800.00; and (+0.9%); and

WHEREAS, Change Order No. 3 is for additional bench and integrally colored bench pad in the amount of \$2,350.00; and (+1.1); and

WHEREAS, Change Order No. 4 is for the removal of existing manifold box and relocate to the concrete; remove new fence to gain access for the machinery to excavate along the fence line to create the trench to accommodate all the PVC Spray Park water lines; build new concrete apron around the manifold box approximately 4' deep; retest for water leaks and pressure testing; PGC back fill, seed and hay upon completion; remove the cabinet around the water meter and furnish and install a new low-profile cage to protect the water meter in the amount of \$37,379.00; and (+4.1%); and

WHEREAS, Change Order No. 5 is for additional hours and materials for water service in the amount of \$3,046.66; and (+4.3%); and

WHEREAS, the request to modify the contract was found to be justifiable by the project consultant and the Director of Public Works/Engineering; and

WHEREAS, Picerno Giordano Construction did submit Change Order No. 1 through No. 5 in the amount of \$53,975.66 (+4.3%); and

WHEREAS, Change Order No. 1 through No. 5 is required to be approved for the construction of Ropes Playground, a copy of which is attached hereto and made a part hereof; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds certifying that funds are available for this change order in Account No. T-11-00-000-000.

Picerno-Giordano Construction was onsite 3/18/2019, Our scheduled work for the day was to excavate to expose water service brought to the curb by Sauger. Connect to said water service, bring copper line into the park side of the project, appropriately backfill and leave the required stub-up for the plumber. When the water line was uncovered it was found out that Sauger switched from Copper to DIP, PG Construction was unaware of this change and did not have the necessary materials onsite to accommodate this change. As a result, the work could not be completed until direction was given by RVE.
