**TITLE:** AN ORDINANCE OF TO AMEND AND SUPPLEMENT THE CODE OF THE CITY OF ORANGE TOWNSHIP CHAPTER 200, ARTICLE II ENTITLED "PARKING" TO REGULATE PARKING OF BOATS. (Sponsored by Council Members Tency Eason and Clifford Ross).

WHEREAS, finding adequate parking is a habitual issue encountered by the residents and patrons of business in the City of Orange Township; and

WHEREAS, the City of Orange Township is consistently looking for new ways to address the parking needs within the City; and

WHEREAS, it has been observed that boats have been parked on City streets utilizing valuable parking space; and

WHEREAS, the parking of boats is currently not regulated in the municipal code; and

WHEREAS, a determination has been made that the municipal code must be updated to regulate parking of boats.

NOW THEREFORE, BE IT ORDAINED by the Municipal Governing Body of the City of Orange Township that the municipal code be amended and supplemented as follows:

**SECTION 1.**

**§ 200-10.4.1. Parking of Boats.**

- A. No person shall park or store a boat, on or off a trailer, on any street or highway within the City of Orange. However, emergency or temporary parking or stopping of a trailed boat is permitted on any street or highway within the City of Orange for not longer than one hour.
- B. As used in this section, the term trailer shall mean any vehicle or structure which is or may be mounted on wheels, having no motive power of its own, and capable for use as a conveyance upon streets or highways.


**SECTION 2. Inconsistencies**

All other ordinances and parts of ordinances in conflict or inconsistent with this ordinance are hereby repealed but only to the extent of such conflict or inconsistency.

**SECTION 3. Headings**

All headings within this ordinance are for convenience only and are not deemed to be part of this ordinance.

This ordinance shall take effect after final passage and upon expiration of twenty (20) days following publication unless otherwise provided by resolution of this City Council.
