**TITLE:** AN ORDINANCE TO AMEND THE CODE OF THE CITY OF ORANGE TOWNSHIP, CHAPTER 200, SECTION 200-33 ENTITLED "SCHEDULE II: NO PARKING CERTAIN HOURS" TO REVISE THE DAYS AND HOURS OF RESTRICTED PARKING ON CLEVELAND STREET. (Sponsored by Council Member Tency Eason).

**WHEREAS**, finding adequate parking is a habitual issue encountered by the residents and patrons of business in the City of Orange Township; and

**WHEREAS**, the City of Orange Township is consistently looking for new ways to address the parking needs within the City; and

**WHEREAS**, it has been observed that additional parking is needed on Cleveland Street; and

**WHEREAS**, a determination has been made that changing the no parking hours on Cleveland Street would create additional parking and that it would be beneficial for the City and members of the public.

**NOW, THEREFORE BE IT ORDAINED** by the City Council of the City of Orange Township as follows:

**SECTION 1.**

Section 200-33, Schedule II: No Parking Certain Hours is hereby amended as follows:

Name of Street	Side	Hours/Days	Location
Cleveland Street	East	<u>6:00 a.m. to 8:00 a.m.</u> <del>AH</del> , Thurs. and Fri.	From Main Street to White Street
Cleveland Street	West	<u>6:00 a.m. to 8:00 a.m.</u> <del>AH</del> , Mon – Wed.	From 213 feet north of Main Street to White Street


**SECTION 2. Severability of Ordinance Provisions**

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity of constitutionality of any other sections or parts thereof.

**SECTION 3. Conflict of Other Ordinance Provisions**

That all ordinances and parts of ordinances and conflicts that are inconsistent with this ordinance are hereby repealed but only to the extent of such conflict or inconsistency.
