WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. requires that the resolution authorizing the award of a contract for "extraordinary unspecifiable services" without competitive bids and that said contract itself must be available for public inspection as set forth herein; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto certifying that funds will be available for this purpose in Account No 4-01-43-490-000-519, contingent upon Council approval and inclusion of said item in the 2024 Budget, there will be sufficient funds to contract ACCURATE LANGUAGE SERVICES, LLC.

NOW, THEREFORE, BE IT RESOLVED, the Municipal Council of the City of Orange Township, New Jersey as follows:

- 1. The Mayor and the Municipal Clerk are herb authorized and directed to execute the attached agreement with Accurate Language Services, LLC, 501 Grand Street, Asbury Park, NJ 07712.

GENERAL SERVICE AGREEMENT

This GENERAL SERVICE AGREEMENT (the "Agreement") dated this 31ST day of July 2024
BETWEEN:

City of Orange Township / City of Orange Township Municipal Court /
City of Orange Township Police Department,
29 Park Street, Orange, NJ 07050, USA
(the "Client")

- AND -

Accurate Language Services of 501 Grand Ave, L-3, Asbury Park, NJ 07712 (the "Contractor").

BACKGROUND:

- A. The Client is of the opinion that the Contractor has the necessary qualifications, experience, and abilities to provide services to the Client.
- B. The Contractor is agreeable to providing such services to the Client on the terms and conditions set out in this Agreement.

IN CONSIDERATION OF the matters described above and of the mutual benefits and obligations set forth in this Agreement, the receipt and sufficiency of which consideration is hereby acknowledged, the Client and the Contractor (individually the "Party" and collectively the "Parties" to this Agreement) agree as follows:

Services Provided

1. The Client hereby agrees to engage the Contractor to provide the Client with services (the "Services") consisting of:

Accurate Language Services will provide the following services on an as needed basis:

- In-Person Interpreting Services
- On-Demand Over the Phone Interpreting Services services will be available 24 hours a day, 7 days a week and 365 days a year, in more than 170 languages
- Pre-Scheduled Virtual Interpreting Services
- Document Translation Services

2. The Services will also include any other tasks which the Parties may agree on. The Contractorhereby agrees to provide such Services to the Client.

Term of Agreement

- 3. The term of this Agreement (the "Term") will begin on August 1, 2024, and will remain in full force and effect until July 31, 2025, subject to earlier termination as provided in this Agreement. The Term of this Agreement may be extended by mutual written agreement of the Parties.
- 4. In the event that either Party wishes to terminate this Agreement prior to July 31, 2025, that Partywill be required to provide at least 60 days' notice to the other Party.

Performance

5. The Parties agree to do everything necessary to ensure that the terms of this Agreement takeeffect.

Currency

6. Except as otherwise provided in this Agreement, all monetary amounts referred to in this Agreement are in US Dollars.

Compensation

- 7. For the services rendered by the Contractor as required by this Agreement, the Client will providecompensation (the "Compensation") to the Contractor as follows:
 - Please see attached Rate Sheets.

For In-Person and Pre-Scheduled Virtual Assignments:

- 24 hours or more advanced cancellation notice: No Charge
- Cancellation with less than 24 hours notice: Total # of requested hours billed.
- -Cancellation upon arrival: total # of requested hours plus travel

Payment Terms:

The City of Orange will make every effort to pay vendors/contractors within thirty (30) to sixty (60) days of receipt of Accurate's invoice.

Invoices will be billed under PO#: TBD.

8. The above Compensation includes all applicable sales tax, and duties as required by law.

Return of Property

9. Upon the expiry or termination of this Agreement, the Contractor will return to the Client any property, documentation, records, or Confidential Information which is the property of the Client.

Capacity/Independent Contractor

10. In providing the Services under this Agreement it is expressly agreed that the Contractor is acting as an independent contractor and not as an employee. The Contractor and the Client acknowledge that this Agreement does not create a partnership or joint venture between them and is exclusively a contract for service.

Notice

- 11. All notices, requests, demands or other communications required or permitted by the terms of this Agreement will be given in writing and delivered to the Parties of this Agreement as follows:
 - a. City of Orange Township29 Park Street, Orange, NJ 07050 USA
 - b. Accurate Language Services501 Grand Ave, L-3, Asbury Park, NJ 07712

or to such other address as any Party may from time to time notify the other.

Indemnification

12. Except to the extent paid in settlement from any applicable insurance policies, and to the extent permitted by applicable law, each Party agrees to indemnify and hold harmless the other Party, and its respective affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever, which result from or arise outof any act or omission of the indemnifying party, its respective affiliates, officers, agents, employees, and permitted successors and assigns that occurs in connection with this Agreement. This indemnification will survive the termination of this Agreement.

Insurance

13. The Contractor will be required to maintain general liability insurance including coverage for bodily injury and property damage at a level that would be considered reasonable in the industry of the Contractor based on the risk associated with the characteristics of this Agreement and onlyto the extent permitted by law. All insurance policies will remain materially unchanged for the duration of this Agreement.

Legal Expenses

14. In the event that legal action is brought to enforce or interpret any term of this Agreement, the prevailing Party will be entitled to recover, in addition to any other damages or award, all reasonable legal costs and fees associated with the action.

Modification of Agreement

15. Any amendment or modification of this Agreement or additional obligation assumed by either Party in connection with this Agreement will only be binding if evidenced in writing signed by each Party or an authorized representative of each Party.

Time of the Essence

16. Time is of the essence in this Agreement. No extension or variation of this Agreement willoperate as a waiver of this provision.

<u>Assignment</u>

17. The Contractor will not voluntarily, or by operation of law, assign or otherwise transfer itsobligations under this Agreement without the prior written consent of the Client.

Entire Agreement

18. It is agreed that there is no representation, warranty, collateral agreement, or condition affecting this Agreement except as expressly provided in this Agreement.

Enurement

19. This Agreement will enure to the benefit of and be binding on the Parties and their respectiveheirs, executors, administrators, successors and permitted assigns.

Titles/Headings

20. Headings are inserted for the convenience of the Parties only and are not to be considered wheninterpreting this Agreement.

Gender

21. Words in the singular mean and include the plural and vice versa. Words in the masculine meanand include the feminine and vice versa.

Governing Law

22. It is the intention of the Parties to this Agreement that this Agreement and the performance under this Agreement, and all suits and special proceedings under this Agreement, be construed in accordance with and governed, to the exclusion of the law of any other forum, by the laws of New Jersey, without regard to the jurisdiction in which any action or special proceeding may be instituted.

Severability

23. In the event that any of the provisions of this Agreement are held to be invalid or unenforceable in whole or in part, all other provisions will nevertheless continue to be valid and enforceable with the invalid or unenforceable parts severed from the remainder of this Agreement.


Waiver


