**Police Department**

Police Chief Vincent Vitiello thanked all for their prayers and positive energy for the Officer injured in the line of duty. Council Vice President Clifford R. Ross encouraged the Police Chief and thanked him and the department for the work they do for the city. Councilmember Kerry J. Coley suggested having Coffee with a Cop on a Saturday.

**Fire Department**

Fire Chief Derrick Brown stated there was a fire on March 10<sup>th</sup> and two people were displaced and no injuries reported.

**Community Service**

Director Wendy Sykes stated the department has several events that can be found on the website. The department is hiring Life guards for the summer. There will be a Easter Brunch on April 10<sup>th</sup> in Council Chambers. Residents can get swim badges from the Department of Recreation. The city will honor women from the city on March 30<sup>th</sup>. Council President Tency A. Eason wants to have the mammogram unit more accessible to residents.

**Tax Assessor**

Director Chris Murray gave an update on the County tax Board of Appeals. Currently the city has 15, eight of which are tax court pending.

**Department of Public Works**

Director Marty Mayes was having difficulty with the wifi.

**Tax Collector**

Director Paula Ferreira stated second quarter taxes are due May 1<sup>st</sup>, and they have until May 10<sup>th</sup> to pay without interest. Councilmember Kerry J. Coley inquired about the tax collection rate which is 99.29%. He congratulated the department on the work they have done.

**Planning Department**

Director Laquana Best stated projects continue to move forward. Code enforcement is working closely with DPW to enforce new ordinance on the garbage project. The residents are not being ticketed as the information is still being distributed.

**Finance**

CFO Nile Clements stated the Finance Department had a few Resolutions on tonight's agenda.

**Administration**

Business Administrator Chris Hartwyk gave further clarification to the garbage Ordinance and how violations will be given. Administration is looking into finding cheaper cans. Councilmember Adrienne Wooten wants to amend the Ordinance to show consideration of the seniors in the city who cannot move a 50 pound can.

When called upon by the Council President, each speaker must enable his/her camera and microphone, and state his/her name and street address before proceeding further. Those unable to activate a camera feed may still be permitted to speak at the Council President’s discretion.

To facilitate maximum public involvement and maintain order, each speaker will have one 5-minute period to interact orally with the Council. Screen-sharing or visual aids will not be permitted. Written comments submitted in advance of this meeting were forwarded to all Council Members, published on the City’s website, and will be appended to final approved minutes – they will not be read aloud, and anyone submitting a written statement will not be permitted to also speak at this meeting. The Council will consider all comments and questions, oral or written, and respond if and when appropriate, which may or may not be during this meeting.

Members of the public are reminded to be courteous and mindful of other individuals’ rights when speaking. A Council meeting is not the proper venue to discuss personal matters or lodge complaints against specific City employees or private individuals who may have personal protections afforded them under State and/or Federal law. Therefore, each speaker should consider how his/her remarks may trigger those protections for anyone identified in or affected by them, and should be aware that they are legally responsible for their own statements. **Aisha Samuel of 401 Highland Terrace** expressed her concerns about the recreations website, swim lessons, activities for seniors but nothing for children, the parking on her block and permit parking.

**Rachel Tennant of 461 Waverly Place** expressed her concern with the city’s pool and its finances, black mold, the water bill envelopes, and who the city’s financial auditors are.

**Sherene Williamson of 447 Alden Street** expressed her concern with recreation for the city and the garbage ordinance as the tops to her new cans has disappeared and she doesn’t want to be ticketed.

**Volora Howell of 483 Mountain View Avenue** expressed concerns about a legal case and the Deputy City Attorney addressed her concerns and gave his number to further discuss the next day.

**Kweli Campbell of Argyle Street** expressed concern for the bike legislation, Metcalf Park safety, and what the impact of affordable housing legislation signed by the governor will be on the city. Councilmember Adrienne K. Wooten addressed concerns about the bike legislation and offered to have further conversation with her off line. Police Chief Vitiello will look into her concerns with the park safety. Director Laquana Best the department is working on the new affordable housing legislation.




