DEPARTMENT MONTHLY REVENUE COLLECTION

Police Department

Police Chief Vincent Vitiello reminded the residents that there would be a PCC Meeting on Wednesday, June 19, 2024, 7:00pm on the second floor of the Police Station. Councilmembers and residents are all welcome to come and have a conversation with the officers. The department was awarded a Fast ID Program from the Criminal Justice Department of the Attorney General. A fingerprint system that would speed up the department's processing. He thanked Councilmember Adrienne K. Wooten for calling him and gave accolades to officers she witnessed with a resident who suffered from mental health. This was a lead into the RISE pilot program. Councilmember Weldon M. Montague, III inquired about permit parking for out of state visitors which the Chief will assist him with. He also addressed home safety to deter from being robbed.

Vincent DeFilippo, Health Officer took questions to relay to Director Wendy M. Sykes.

Tax Assessor

Director Chris Murray gave an update on the County Boards. The first hearing date was on the June 13th, there were 45 cases scheduled. Eight were settled, four were tried and thirty-three were dismissed due to lack of prosecution. There are ten more cases that are coming up at the next hearing.

Tax Collector

Director Paula Ferreira stated quarter estimated taxes bills will mailed out shortly, the last day to pay without interest is Monday, August 12th.

Department of Public Works

Director Marty Mayes had nothing to report but was open for questions. Council President Tency A. Eason inquired about paving on Cleveland Street and he will investigate.

Fire Department

Fire Chief Derrick Brown stated there was nothing to report on the fire side. He spoke about the JPSA orientation on July 1st and applications can be found the website. The program starts on July 8th for children 8-11. He gave locations of cooling stations. Councilmember Weldon M. Montague, III reminded residents that there a no passes need for the pool during the heatwave.

Planning Department

Director Laquana Best wished a belated Father's Day to all of the Fathers on the call. The 4th Annual Tri-Community Commercial and Residential Development Seminar (East Orange, Irvington, and the City of Orange Township) will be held Wednesday, June 26, 2024, 6:00pm – 8:00pm at Sandwiches Unlimited, 23 North Center Street, Orange. The Clerk's Office has distributed the flier as residents must register for this event. Councilmember Quantavia L. Hilbert inquired about the developer on Mountain Avenue and Scotland Road working past the time allotted. The Business Administrator gave his number (973-280-2587) for residents who would like to call and make a complaint about this issue.

Law Department

Attorney Gracia R. Montilus, Esq. wanted to make the Councilmembers aware that on June 3rd, Governor Phil Murphy signed into legislation, a new law mandating access to periodic cancer screening for fire fighters. On June 5th there was a law making various changes to the process accessing government records. The law now encourages public records to be placed on agency websites so they are readily accessible. He will prepare a full memo to Councilmembers with this information. Council President Tency A. Eason stated that Governor Murphy will be at St James to start a committee to assist inmates who would like clemency.
