**CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS**

The City Clerk announced that members of the public wishing to address the Council may do during this portion of the meeting. Speakers must sign their name on the Comments Sign-Up sheet and approach the microphone, when called upon. To allow maximum public involvement, each speaker is permitted one 5-minute period to interact with the Council and must provide his or her name and street address prior to beginning any remarks. Visual aids are not permitted.

Speakers are reminded to be courteous and mindful of other individuals. Each person has the right to speak on any subject but is responsible for abuse of that right. The City bears no liability for any comments made by the public and maintains discretion to remove any person engaging in obscene or disruptive conduct. The Council will consider all comments and questions, and will respond, if and when appropriate, which may or may not be during this meeting.

**Rachel Tennant of 461 Waverly Place** inquired about Council Meeting notifications, Zoom meetings, City Attorney's presence and if they are paid extra for attendance, legislation on the agenda pertaining to lawsuits, Street Sweeper repairs, and the tree stump created by Verizon. The Business Administrator Chris Hartwyk addressed the street sweepers, lawsuits and the Attorney fees.

**Janicea Jones-Vance of 214 Duane Street** wanted an update regarding the library. The Business Administrator Chris Hartwyk will set up a meeting to discuss her concerns.

**Aisha Samuel of 401 Highland Terrace** expressed concerns about Highland Road being repaved which should happen in the spring through a grant. She also had concerns about her driveway still being blocked.

**Gloria Stewart** stated her address is so noted on the sign in sheet. She has positioned herself in a different seat at this week's Council Meeting so she would be able to visually see all the Councilmembers. She struggles to attend the meetings but is happy to be at the in-person Council Meeting. She has a great concern with parking, Peek Development, and residents of East Orange is parking in Orange. She also spoke about traffic issues dealing with the traffic lights sequences.

**Dr. Gloria Boseman of 345 Olcott Street** inquired about how she can obtain more information on construction going on in the city as she wants to know what the city is getting out of all the construction. She expressed concern about community impact, influx on residents, the Health and Wellness Center being proposed for the YMCA, vacancy rates, programs for adolescence, the former Police Station, robo calls to inform residents of events, and calendars for seniors' activities. Business Administrator Chris Hartwyk stated the impact statements are on file with the Clerk's Office and the redevelopment agreement on the Wellness Center is being negotiated now. Council President Adrienne K. Wooten will check on the robo call and the master calendar.

**Honorable Harold Johnson of 234 Fuller Terrace** stated the month of September is Life Insurance month. He wanted to discuss statistics of life insurance which he will leave in the Clerk's Office for Councilmembers to review.

**COUNCIL COMMENTS**

**Council Vice President Tency A. Eason** informed residents about the upcoming event at St Matthews AME Church, 336 Oakwood Avenue on Thursday, September 19, from 10:00am-2:00pm. The Department of Motor vehicles (DMV) will be on hand to provide services. Residents should register but they may accept walk-ins. There is a wait for those who do not register. They will have a second event on October 21<sup>st</sup>. On Thursday, September 26<sup>th</sup> from 6:00-9:00pm at Cross and Crown, 476 Thomas Blvd., there will be a First Time Home Buyers Seminar presented by Essex County. She inquired about background checks for people who volunteer around children and gave condolences to the family of Thomas Edwards.

**Councilmember Clifford R. Ross** expressed concerns about parking on Highland, the Parking Authority, the Lincoln Avenue Police Department, Valley Road trial period change of direction (this is a project with neighboring city, West Orange), potholes on Scotland Road, and the 6-9 Program including more educational activities to equip our youth for success. He encouraged residents to vote in the election tomorrow and then 48 days from now on November 5<sup>th</sup> for the Presidential election.

**Councilmember Quantavia L. Hilbert** gave condolences to Thomas Edwards family and the Hill family who are West Ward residents. She spoke to the recent incident that took place at Metcalf Park and hopes the Police Department can do an active shooter drill. September 19<sup>th</sup> and 20<sup>th</sup> from 3-5pm at the Orange Public Library, there will be a recruitment event for Girl Scouts in the City of Orange. The West Ward will hold a Meeting on September 26<sup>th</sup> at 6:00pm. October 12<sup>th</sup> from 10-1pm there will be a Day of Service – a cleanup event and she is looking for volunteers. She inquired about repaving the Municipal parking lot which the Business Administrator Chris Hartwyk is looking for grant funds to do so. She also inquired about the old Police Station and what can be done with this unkept property. Business Administrator Chris Hartwyk explained the property is not owned by the city anymore.

**Councilmember Weldon M. Montague, III** stated the city has been hit hard with untimely deaths and he gave his condolences to the Edwards family. He inquired about Resolution 417-2024 and Business Administrator Chris Hartwyk explained this is a matching grant. He also inquired about e-ticket machines which was addressed by the Business Administrator.

**Councilmember Kerry J. Coley** spoke about the Shredding event coming on October 12<sup>th</sup>. He also spoke about the First Time Home Buyer Seminars and encourage residents to check on their credit. He discussed the work being done on Main Street and inquired if PSE&G will repave when it is complete.

**Councilmember Jamie B. Summers-Johnson** gave condolences to the Edwards family. She thinks Active Shooter training is being done. She agrees with her Council colleague about upgrading the 6-9 Program. Residence should know if their students do not attend school in the city they can still attend the programs. She acknowledged two Principals in the city, Ms. Woods and Principal Cook. She was pleased with the city's Debate Watch party. There will be a South Ward meeting in Council Chambers on October 23<sup>rd</sup>. There will be a Homecoming game between Orange and East Orange which will include Tailgating as well.

Council Vice President announced a book signing at East Orange Public Library on Thursday Sept 19<sup>th</sup> from 4:30-6:30pm. She stated the Planning Board has started planning for the old Police Station. Pink Out for Orange and East Orange will be held on October 5, 2024 from 10am-3pm. You can register at Elmwood Park.

Councilmember Clifford R. Ross stated there is a Senior Wellness Day at next Tuesday, September 24<sup>th</sup>.

**Councilmember Adrienne K. Wooten** will bring back Coffee and Conversations. Christopher's initiatives will be launched and she is seeking to engage anyone who is interested.
