The City Clerk announced that the requirements of N.J.S.A. 10:4-9 et. seq., "Sunshine Law" has been met. Council President directs Clerk to file reports.

Fire Department

Fire Chief Derrick Brown stated the city has been safe on the fire side. He commended the Recreation Department for the Easter Egg Hunt which the Fire Department supported. Council President Tency A. Eason inquired about lithium battery safety which the Fire Chief will distribute information.

Tax Collector

Director Paula Ferreira reminded residents that the second quarter taxes are due on May 1st and the easiest way to pay is on the city's website.

Department of Public Works

Director Marty Mayes stated the Shredding event will be this Saturday, April 6th from 9-12pm at City Hall. Councilmember Kerry J Coley inquired about cleaning for an abandoned house which DPW will take a look at tomorrow. Director Mayes also informed Councilmembers that changing direction on streets is actively being worked on, construction on the basketball courts has been paused due to weather, and the department is exploring different ways for dividers near Dunkin Donuts. Councilmember Kerry J. Coley had a concern about a sink hole near Hampton Terrace.

Finance

CFO Nile Clements stated there is legislation on the agenda from the Finance Department that he wanted the Councilmembers to adopt. Councilmember Kerry J. Coley inquired about the bill list which CFO Nile Clements explained that they rolled over 14.6 million dollars in bond anticipation notes in March and the Health Insurance Bill was also included in this amount.

County Liaison

Reginald Bledsoe stated he could set up a discussion through the Clerk's Office along with the Business Administrator to allow Councilmembers to address their concerns with DPW. Councilmember Kerry J. Coley inquired about a permit to park ordinance for residents who live on Central Avenue that was kicked back. Mr. Bledsoe will revisit this after conversations with the Councilmember. Councilmember Weldon M. Montague, III requested more signage on Scotland Road. Councilmember Quantavia L. Hilbert inquired about Scotland Road traffic issues and the YMCA Sale which Business Administrator Chris Hartwyk addressed her concerns.

Those unable to activate a camera feed may still be permitted to speak at the Council President's discretion.

To facilitate maximum public involvement and maintain order, each speaker will have <u>one</u> 5-minute period to interact orally with the Council. Screen-sharing or visual aids will not be permitted. Written comments submitted in advance of this meeting were forwarded to all Council Members, published on the City's website, and will be appended to final approved minutes – they will not be read aloud, and anyone submitting a written statement will not be permitted to also speak at this meeting. The Council will consider all comments and questions, oral or written, and respond if and when appropriate, which may or may not be during this meeting.

Members of the public are reminded to be courteous and mindful of other individuals' rights when speaking. A Council meeting is not the proper venue to discuss personal matters or lodge complaints against specific City employees or private individuals who may have personal protections afforded them under State and/or Federal law.
