A RESOLUTION AUTHORIZING AN AGREEMENT WITH WOODARD & CURRAN, INC., 12 MOUNTFORT STREET, PORTLAND, ME 04101 (NEW JERSEY BRANCH LOCATED AT 50 MILLSTONE ROAD, BUILDING 400, SUITE 201, EAST WINDSOR, NEW JERSEY 08520) FOR WATER/SEWER CONNECTIONS AND/OR DISCONNECTIONS, OVERSIGHT AND INSPECTION SERVICES COMMENCING JANUARY 1, 2024 THROUGH DECEMBER 31, 2024 WITH ALL FEES PAID EXCLUSIVELY THROUGH ESCROWED FUNDS.

WHEREAS, the City of Orange Township has a need to acquire a contractor to provide water/sewer connections and/or disconnection; oversight and inspection services on an "as needed" basis; and

WHEREAS, the fees for said services will be paid separately from the budget and received through an escrow account that will be solely funded by developers pertaining to their specific projects; and

WHEREAS, a Certification of Availability of Funds is not necessary since the fees for the water/sewer connections and/or disconnections will be paid exclusively by applicants, as appropriated.

**NOW, THEREFORE, BE IT RESOLVED** that the Municipal Council of the City of Orange Township that an agreement be awarded to Woodard & Curran, Inc., with all fees paid separately from the budget and received from establishing an escrow account that will be solely funded by developers pertaining to their specific projects; and

BE IT FURTHER RESOLVED, that the proper officers of the City of Orange Township are hereby authorized to enter into said agreement with Woodard & Curran, Inc.; and

**BE IT FURTHER RESOLVED** that notice of this action shall be published as required by law within 10 days of its passage.

# **AGREEMENT**

This Agreement, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2023, between the City of Orange Township and Woodard & Curran, Inc., 12 Mountfort Street, Portland, ME 04101 (New Jersey Branch located at 50 Millstone Road, Building 400, Suite 201, East Windsor, New Jersey 08520).

WHEREAS, the City of Orange Township wishes to retain a firm for water/sewer connections and/or disconnections with all fees paid exclusively through escrowed funds for the City of Orange Township on an "as needed" basis for the period of January 1, 2024 through December 31, 2024.

WHEREAS, the City of Orange Township wishes to retain Woodard & Curran, Inc., 12 Mountfort Street, Portland, ME 04101 (New Jersey Branch located at 50 Millstone Road, Building 400, Suite 201, East Windsor, New Jersey 08520).

WHEREAS, this firm and the individuals of the firm are to be retained pursuant to the Agreement as specified; and

WHEREAS, the City Council of the City of Orange Township has, by

Resolution No.\_\_\_\_\_-2024 dated \_\_\_\_\_\_\_, 2024, authorizes Woodard & Curran, Inc.

for the purpose of water/sewer connections and/or disconnections with all fees paid exclusively through escrowed funds.

NOW, THEREFORE, BE IT AGREED by and between the parties, for the mutual convenient set forth herein below:

 Woodard & Curran, Inc. is hereby contracted by the City of Orange Township to provide services as specified.

- 2. This agreement shall be effective commencing on **January 1**, 2024 and terminating on **December 31**, 2024.
- 3. This agreement shall not be assigned nor shall any duties under this agreement be delegated by **Woodard & Curran**, **Inc.** without prior written consent of the City.
- 4. The validity of this agreement and its terms or provisions, as well as the rights and duties of the contracting parties, shall be governed by and construed in accordance with the laws of the State of New Jersey.
- 5. This agreement shall be binding on and inure to the benefit of the contracting parties and their respective heirs, executors, administrators, legal representatives, successors, and assigns when not expressly prohibited by this agreement.
- 6. In case any one or more of the provisions contained in this agreement shall for any reason be held to be invalid, illegal or unenforceable in any respect, the invalidity, illegality, or unenforceability shall not affect any other provision of it this agreement shall for any reason be held to be invalid, illegal, or unenforceable provision had never been contained in it.
- 7. This agreement constitutes the sole agreement of the contracting parties and supersedes any prior understandings or written or oral agreements between the parties respecting its subject matter.
- 8. All notices and other communications shall be sent by certified mail, return receipt requested, and shall be deemed to have been given when sent to the parties at their respective addresses as set forth above, unless a different

address has been selected after the execution of this agreement and has been duly communicated to the party giving notice.

9. The City may terminate this Agreement upon three days notice with Woodard & Curran, Inc. In the event that this agreement is deemed to be terminated, the City shall pay Woodard & Curran, Inc. for those services provided as of the effective date of termination. This agreement is final and cannot be amended, supplemented, changed or modified without said being in writing.




Congratulations! You are now registered with the New Jersey Division of Revenue.

Use the Taxpayer Identification Number listed above on all correspondence with the Divisions of Revenue and Taxation, as well as with the Department of Labor (if the business is subject to unemployment withholdings). Your tax returns and payments will be filed under this number, and you will be able to access information about your account by referencing it.

Additionally, please note that State law requires all contractors and subcontractors with Public agencies to provide proof of their registration with the Division of Revenue. The law also amended Section 92 of the Casino Control Act, which deals with the casino service industry.

We have attached a Proof of Registration Certificate for your use. To comply with the law, if you are currently under contract or entering into a contract with a State agency, you must provide a copy of the certificate to the contracting agency.
