Councilmember Weldon M. Montague, III inquired about the expired driver's license and the body will table the ordinance until the documents are updated.

ORDINANCES - INTRODUCTION | FIRST READING

50-2024 An ordinance to amend the Code of the City of Orange Township, Chapter 200, entitled "Vehicles and Traffic", Section 200-52-1 Handicapped Parking Spaces. (471 Hillside Avenue)

Council Vice President Tency A. Eason inquired about the driver's license expiration which the Business Administrator Chris Hartwyk stated the Department of Public Works Director, Marty Mayes had the updated document. Councilmember Kerry J. Coley also expressed concerns about it.

*500-2024 A resolution authorizing the awarding of a contract for the 2022 NJDOT Safe Streets to Transit Project Orange Transit Station Underpass and Railroad Place Improvement Project to Portofino Builders, LLC, 69 Irwin Street, Springfield, New Jersey 07081 in the amount not to exceed \$229,535.00.

Council Vice President Tency A. Eason asked for more information. Business Administrator Chris Hartwyk stated there will be new sidewalks, curbs and lighting. The underpass at Railroad Place.

*508-2024 A resolution authorizing payment to Hillman Consulting, LLC, 1600 Route 22 East – First Floor, Union, New Jersey 07083 for the Hazardous Discharge Site Remediation Fund Application at 540 Mitchell Street in the amount not to exceed \$39,693.50.

Councilmember Kerry J. Coley asked for further information. Business Administrator Chris Harwyk stated this is property 540 Mitchell Street which has been in the site remediation program for over a decade and was originally owned by the city but sold to a private party about three to four years ago. The site remediation plan is still in effect, and it is all a part of the bid. Even though the city sold the property, the city is still responsible for remediation.

*510-2024 A resolution appointing Lavon Boykins, a resident of Orange, New Jersey as a Commissioner Member to the Housing Authority of the City of Orange Township, New Jersey for a term of five (5) years. (Sponsored by Council Member Quantavia L. Hilbert)

Councilmember Quantavia Hilbert wants to pull this resolution for a separate vote to make a statement.
