WHEREAS, there exists a need for additional funds for parts, repairs and services and

WHEREAS, pursuant to Resolution #199 -2025 initially authorized to provider services for parts, services and repairs for two (2) Ravo 5i Street Sweepers in an amount not to exceed \$20,000.00; and

WHEREAS, the current request to increase the contract amount an additional \$4,000.00 is for additional parts and services and current bills for services render and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto and made part hereof, certifying that funds are available for this purpose in the Account No. 5-01-26-315-000-528 there will be sufficient funds to contact Northeast Sweeper.

NOW, THEREFORE, BE IT RESOLVED that the proper officers of the City of Orange Township are hereby authorized to enter into an addendum agreement with Northeast Sweepers for parts, services, and repairs in the amount not to exceed \$24,000.00.

AGREEMENT

This Agreement made and entered into this 1st day of April 2025, between the City of Orange Township and **Northeast Sweepers and Rentals Inc under the Keystone Purchasing Network (KPN) Contract # KPN -202012-05.**

WHEREAS, the City of Orange Township wishes to retain a firm for **Street Sweeper rental, parts and service.** The City of Orange Township, as specifically set forth in the attached proposal in the amount not to exceed **\$20,000.00.**

WHEREAS, the City of Orange Township wishes to retain **Northeast Sweeper and Rental Inc**, with offices located at **20 Montesano Rd Fairfield, New Jersey 07004.**

WHEREAS, this firm and the individuals of the firm are to be retained pursuant to the Agreement as specified under the KPN Contract # 202012-05 and

WHEREAS, the City Council of the City of Orange Township has, by **Resolution No. 199-2025** dated April 1, 2025 authorizes **Northeast Sweeper and Rentals Inc., for Sweeper rental, parts and services** as specified in the attached proposal.

NOW, THEREFORE, BE IT AGREED by and between the parties, for the mutual convenient set forth herein below:

1. **Northeast Sweepers and Rentals Inc**, is hereby contracted by the City of Orange Township to provide services as specified in the attached proposal.
2. This agreement shall be effective commencing on **January 1, 2025** and terminating on **December 31, 2025**
3. This agreement shall not be assigned nor shall any duties under this agreement be delegated by **Northeast Sweepers and Rentals Inc**, without prior written consent of the City.

4. The validity of this agreement and its terms or provisions, as well as the rights and duties of the contracting parties, shall be governed by and construed in accordance with the laws of the State of New Jersey.
5. This agreement shall be binding on and inure to the benefit of the contracting parties and their respective heirs, executors, administrators, legal representatives, successors, and assigns when not expressly prohibited by this agreement.
6. In case any one or more of the provisions contained in this agreement shall for any reason be held to be invalid, illegal or unenforceable in any respect, the invalidity, illegality, or unenforceability shall not affect any other provision of it this agreement shall for any reason be held to be invalid, illegal, or unenforceable provision had never been contained in it.
7. This agreement constitutes the sole agreement of the contracting parties and supersedes any prior understandings or written or oral agreements between the parties respecting its subject matter.
8. All notices and other communications shall be sent by certified mail, return receipt requested, and shall be deemed to have been given when sent to the parties at their respective addresses as set forth above, unless a different address has been selected after the execution of this agreement and has been duly communicated to the party giving notice.
9. The City may terminate this Agreement upon three days notice with
Northeast Sweepers and Rentals Inc, In the event that this agreement is deemed to be terminated, the City shall pay **Northeast Sweepers and Rentals Inc**, for those services provided as of the effective date of termination. This agreement is final and cannot be amended, supplemented, changed or modified without said being in writing.
