TITLE: A RESOLUTION APPROVING OFFICIAL PUBLICATIONS FOR YEAR 2026

WHEREAS, state law requires that all legal notices required by law for the City of Orange Township (the "Township") be advertised in local newspapers if one is published in the municipality or county until March 1, 2026; and

WHEREAS, pursuant to P.L. 2025, c.72, starting March 1, 2026, all legal notices required by law for the Township will be published on the Township's official website and in the Secretary of State notices page once the link is provided by the State of New Jersey; and

WHEREAS, it is necessary to designate legal publications for the year 2026 for all required legal notices; and

NOW, THEREFORE BE IT RESOLVED, that the City of Orange Township, County of Essex, State of New Jersey that all public notices will be available at: <http://www.orangenj.gov> starting March 1, 2026, in compliance with P.L. 2025, c. 72, and a copy of the same will be published in the Secretary of State notices page at a link to be provided by the State; and

NOW, THEREFORE BE IT FURTHER RESOLVED, that the official publications for the City of Orange Township until March 1, 2026 shall be *The Record Transcript* and *The Star Ledger* for the advertising of legal notices, and on and after March 1, 2026 all public entity legal notices will be available at <http://www.orangenj.gov> and the Secretary of State website once the link is provided.


