In accordance with N.J.A.C. 7:14A and the City of Orange Township's **Tier A Municipal Stormwater General Permit**, a semi-annual Public Information Session is required during the development of a Watershed Inventory Plan.

The purpose of this Public Information Session is to provide residents and members of the public with information regarding the Phase 1 Watershed Inventory Plan, provide an opportunity to ask questions and offer comments, and receive public input concerning stormwater management and watershed-related matters within the City of Orange Township.
